WHAT THE FEE COVERS

3 day registration (6, 7, 8 August 2008)

Access to all Workshop and all Conference sessions and presentations, lunches, refreshments, receptions and the Conference Dinner on 7th August. The rate is not reduced if you decide not to attend the dinner

2 day registration (7, 8 August 2008)

Access to Conference sessions and presentations, lunches, refreshments, receptions on 7th and 8th August 2008. The rate is not reduced if you decide not to attend the dinner.

1 day registration (Single Day; 6, 7, 8 August 2008)

Access to Conference/Workshop sessions and presentations, lunch and refreshments on that day. Dinner is not included on any 1 day registration.

PRESENTATIONS

Papers provided by the presenters and workshop leaders will be made available after the conference to delegates via the website.

PAYMENT
